

2014 FINANCIAL AID CALENDAR

It's very important that you review the financial aid calendar and are aware of the various deadlines. Due to federal, state and institutional regulations, if the appropriate financial aid paperwork is not submitted in its entirety by the deadlines, you will be ineligible to receive assistance for the semester or academic year in question. In such cases, you will be 100% responsible for any outstanding bill, without financial assistance. Periodically the OSFA will send reminders about missing paperwork, but ultimately it is your responsibility.

1	Free Application for Federal Student Aid (FAFSA) available online for the 2014-15 academic year.
4	First financial aid disbursement to students' account for spring 2014 semester.
8-10	First refunds for students with financial aid exceeding university charges for the spring 2014 semester.
13	Classes begin for spring 2014 semester.
24	Last day to complete late registration or drop a class (spring 2014 semester) for it to be considered when determining financial aid eligibility for the spring 2014 semester.
February	
1	Summer 2014 semester Financial Aid application available.
15	Priority deadline for submitting the 2014-15 academic year FAFSA.
March	
10-14	Financial Aid Awards for the 2014-15 academic year begin to be made available online to new students.
15	Last day to submit Satisfactory Academic Progress Appeal for spring 2014.
April	
1	Priority deadline for submitting the Financial Aid application for the summer 2014 semester.
7-11	Financial Aid Awards for the summer 2014 semester begin to be made available online to students.
18	Last day to submit any outstanding documents for the spring 2014 semester.
25	Last day to accept financial aid awards and sign promissory notes for the spring 2014 semester.
May	
9	Spring 2014 semester ends.
15-16	Annual Satisfactory Academic Progress review and students notified accordingly of financial aid eligibility for summer 2014, fall 2014 and spring 2015 terms.
19	Classes begin for 4-week summer 2014 session.
20	First financial aid disbursement to students' account for summer 2014 semester.
21	Last day to complete late registration or drop a class (4-week summer 2014 session) for it to be considered when determining financial aid eligibility for the summer 2014 semester.
22-23	First refunds for students with financial aid exceeding university charges for the summer 2014 semester.
23	Last day to submit the Financial Aid application or any other outstanding documents for the summer 2014 semester for those only enrolled in the 4-week session.

30	Last day to accept Federal Loans and complete a Perkins Promissory note for the summer 2014 semester for those only enrolled in the 4-week session.
June	
1	Last day to submit Satisfactory Academic Progress Appeal for summer 2014.
2-6	Financial Aid Awards for the 2014-15 academic year begin to be made available online to continuing students.
13	4-week summer 2014 session ends.
15	Last day to pay any waivers/assistantships/fellowships for the fall 2013 and spring 2014.
16	Classes begin for 8-week summer 2014 session.
20	Last day to complete late registration or drop a class (8-week summer 2014 session) for it to be considered when determining financial aid eligibility for the summer 2014 semester.
20	Last day to submit the Financial Aid application or any other outstanding documents for the summer 2014 semester.
23	Last day to accept Federal Loans and complete a Perkins Promissory note for the summer 2014 semester.
23	Last day to accept all types of financial aid awards and sign Direct Loan promissory notes for the summer 2014 semester.
July	
1	To receive full consideration for need-based institutional funds for the 2014-15 academic year, must have submitted all documents in their entirety.
1	Last day to submit Health Professions Verification Worksheet for College of Dentistry and College of Pharmacy students for the 2014-15 academic year.
25	Recommended date in which financial aid awards should be accepted and any additional requirements such as promissory notes, loan counseling, etc., should be completed for the fall 2014 term.
August	
8	8-week summer 2014 session ends.
16	First financial aid disbursement to students' account for fall 2014 semester.
20-22	First refunds for students with financial aid exceeding university charges for the fall 2014 semester.
25	Classes begin for fall 2014 semester.
September	
5	Last day to complete late registration or drop a class (fall 2014 semester) for it to be considered when determining financial aid eligibility for the fall 2014 semester.
October	
15	Last day to submit Satisfactory Academic Progress Appeal for fall 2014.
15	Last day to pay any waivers/assistantships/fellowships for the summer 2014 semester.
November	
3	Financial Aid Awards for the 2014-15 academic year begin to be made available online to students starting in the spring 2015 semester.
26	Last day to submit any outstanding documents for the fall 2014 semester.
December	
5	Last day to accept financial aid awards and sign promissory notes for the fall 2014 semester.
12	Fall 2014 semester ends.
